 - a. Motion by Brittney to approve the minutes. Seconded by Shirley. Minutes approved.

3. 2022-2023 Executive Roles

- a. Following the annual meeting of June 18th, this meeting is to confirm the results of the voting.
 - i. President: Alec Schmitt elected to replace Ikaika Young
 - ii. Vice President: Brittney Shiue continues term
 - iii. Secretary: Michaela Dorf continues term
 - iv. Treasurer: Kristin Velasco elected to replace Izumi Harukuni
 - v. Fan Jiang added as a general board member.
- b. Alec and Kristin need to be added to bank accounts, Ikaika and Izumi to be removed.
- c. Going forwards it is proposed to hold a follow up meeting one week after the annual general meeting to officially confirm any changes to the board and allow changes to banking details to be made in a timely manner.
 - i. Plan to have account transferred over by the end of July.
 - ii. Follow this with the annual budget meeting in August 2022/23 budget meeting planned for August 2nd at 7pm.

4. WSC Skate School Introductory Memberships

- a. There has been some confusion on the exact process for skate school memberships and the timeline that these should be processed. Some membership applications seem to have fallen through the cracks and not sure why.
- b. Shirley explained the process for regular memberships as she receives an email from the website which she forwards on to Eunice. There are some special cases which require a refund but this is in hand.
- c. Introductory memberships follow a different process and Shirley does not get a notification about these. Apparently there are 4 pending memberships for skaters planning to compete at the Sherwood Invitational. The deadline for this competition is July 25th so they need to be processed as soon as possible.
 - i. Shirley suggested contacting Eunice directly with the specific names and details.
 - ii. Brittney said she has spoken with Eunice about these particular skaters already and Eunice is working on it.

New Business

- Shirley welcomed Fan to her first board meeting.
- Lara gave a quick update on Junior Board activities.
 - Senior spotlight
 - o Looking for a location to hold the car wash fundraiser
 - Helped out with the summer party but did not do the games planned due to the weather
 - Have not been helping with skate school as Coach Kelly does not need assistance during the slower summer months.

- Lara is looking for advice on a situation that has arisen within the Junior Board.
 She has received a request from one of the members for the removal of three out of four of the elected officers since they are no longer skating. There does not seem to be any guidelines pertaining to this other than that officers need to be club members, which they are.
 - Alec suggested that this is something which needs to be discussed with all junior board members to determine a way forward. This would effectively be a byelaw change which needs input from the whole membership and would take time.
 - Kristin suggested that this would be a good opportunity to develop the guidelines so that it is clear for the future.
 - Shirley stated that even though they are not competing now, they are still experienced skaters and in a good position to mentor younger skaters.
 - Brittney recommended not making changes right away as the officers have only just been voted in by the membership but starting a discussion with all members to create a policy going forwards.
- Vote on OSC delegates
 - 4 delegates voted Alec, Brittney, Kristin, Shirley
- Alec informed the board that the club contributed the \$4,500 (plus \$30 transaction fee) to cover the coaching fees for Ralph Burghart and Keegan Messing. This was approved by the board via email communication on July 14th 2022 with 5 yes votes and 2 abstentions.
